 Sparing a few mature trees at the perimeter is not good enough for residents of
 Brunswick and Coburg who use the park and station. Residents of Coburg and
 Brunswick already experience hotter temperatures than those living in parts of
 Melbourne with better, more established trees canopy. New trees will not be the
 same and may not survive to grow to the size of these trees.
